#### Item 5 Financial report

Patti Conner gave financial reports to the committee Regarding the 2022 Region 3 Championships. A budget report for 2023 was presented along with a profit and loss and balance sheet. Each State chair was asked to confirm they had received their first bankruptcy payment. Four of the Five states had filed the appropriate paperwork to receive these payments and will check the account to confirm they have received the payment.

Each state is required to submit a financial report the following reports were received North Texas

New Mexico's funds are included in the Region 3 bank account.

Patti also informed the committee that anyone receiving funds from USAG whether they are being reimbursed for travel, prize money etc will receive a 1099 at the end of the year. The need to communicate this with coaches athletes and parents is important so there are no problems at the end of the year

Reminders were given that W-9's are mandatory for USAG to send out any requested funding.

The struggles of the financial aspect with USAG were discussed and possible ways to mitigate the issues.

Total funding to date for Region 3 members is, \$982,936.25

Total for 2022/2023 \$46,184.36.

Region 3 should cross the one million dollar mark in 2023/2024 session.

#### Item 6 Board Member Reports / Election updates

South Texas Chair:

Michael Lachner gave a brief report that their state championship made money this year, they will be hosting a clinic in June for those that made their State team based on results at State.

#### Oklahoma State Chair:

Matt Hinds reported that they had 130 athletes for state championships They co-hosted with a club and are working to finish up all financial reports.

#### North Texas State Chair:

Holly Garrington gave a report in regards to their lower and upper level clinics. Their State Championships was a big success and made money that can be used for athlete, coaches and judges education and schoalrships.\$27,000.00. North Texas gave their first 1<sup>st</sup> Academic scholarship

Gyms were given the opportunity to earn money \$1000/\$1000 to provide volunteers for both set up and tear down Only one club applied and was awarded the spots and was paid \$2000.00

Holly ask for feedback from the other states on what they do for awards. The cost is beginning to be an issue and the states were encouraged to think outside the box.

#### Technical Chair:

Wyatt Moore reported that judging went well this year, he will encourage all judges to test up next year.

Coaches Representative - Wayne Downing

Wayne – Coaches Rep reported that he receives calls or text weekly asking questions Coaches have request that the program provide a definition of spotter in the T210.

Coaches have expressed concerns regarding Virtual Elite Mobility. Concerns and request for consideration include.

- Provide both live and virtual mobility opportunities.
- Revisit requirements, as they feel the skills are arbitrary.
- Request for specific feedback when an athletes fails
- Concerns that this further separates the elites from Dev kids
- When coaches don't use progressions they feel these combos and drills could be unsafe for athletes to try
- Level 10 are required to do more than YE.
- More skill options on DMT

#### West Texas State Chair:

Alyssa Williamson reported that West Texas championships ran out of medals and they are rectifying the shortage. The event did make money to be used for athletes, coaches and judges support.

#### New Mexico State:

Chair Shelli Taylor reported they are losing another gym so they will be back to two. They will continue to combine their state championships with West Texas.

#### Item 7 State Committee and State Chair Elections
